THE REORGANIZATION MEETING OF THE BOARD OF SUPERVISORS OF SCHUYLKILL TOWNSHIP WAS HELD ON TUESDAY 1/3/17 IN THE MUNICIPAL BUILDING AT 6:00PM. MEETING OPENED WITH PLEDGE OF ALLEGIANCE TO THE FLAG. ROLL CALL TAKEN. PRESENT WERE CHARLES FAYASH, FRANK FABRIZIO & NATASHA TYSON.

PUBLIC COMMENT ON REORGANIZATION MEETING ITEMS ONLY:

CHRISTINE VERDIER, MARY D-QUESTIONED IF ANY OF THE APPOINTMENTS WILL BE CHANGING FOR THIS YEAR. FAYASH STATED THAT THEY DID NOT DISCUSS DUE TO IT WOULD VIOLATE THE SUNSHINE LAW.

THE REORGANIZATION MEETING:

THE MEETING STARTED WITH **CHARLES FAYASH** ASKING FOR A MOTION TO APPOINT A TEMPORARY CHAIRPERSON. **FRANK FABRIZIO** NAMED CHARLES FAYASH. SECONDED BY **FAYASH**. *ROLL CALL-ALL APPROVED.* **CHARLES FAYASH** TOOK OVER AS TEMPORARY CHAIRMAN.

CHARLES FAYASH MADE A MOTION TO APPOINT NATASHA TYSON AS TEMPORARY SECRETARY/TREASURER. SECOND BY **FABRIZIO**. *ROLL CALL-ALL APPROVED.*

CHARLES FAYASH ASKED FOR A MOTION TO APPOINT A CHAIRPERSON. **FRANK FABRIZIO** MADE A MOTION TO APPOINT CHARLES FAYASH. SECONDED BY FAYASH. *ROLL CALL-ALL APPROVED.*

CHARLES FAYASH MADE A MOTION TO APPOINT CHARLES HOSLER AS VICECHAIRMAN. SECONDED BY FABRIZIO. *ROLL CALL-ALL APPROVED.*

CHARLES FAYASH STATED NATASHA TYSON WAS APPOINTED AS SECRETARY/ TREASURER AT A PAY RATE OF \$13.00/HR FOR A TOTAL OF 29 HOURS PER WEEK WITH A 2% BONUS ON GARBAGE COLLECTIONS AND \$150 MONTHLY STIPEND FOR PERSONAL VEHICLE USAGE. SECOND BY FABRIZIO. *ROLL CALL-ALL APPROVED.*

CHARLES FAYASH MADE A MOTION TO PAY THE TOWNSHIP AUDITORS AT A RATE OF \$10.00 PER HOUR. THIS INCLUDES: AGNES KANE, ELIZABETH MATALAVAGE, & JESSICA TIRPAK. SECONDED BY FABRIZIO. *ROLL CALL-ALL APPROVED.*

CHARLES FAYASH MADE A MOTION FOR A ROAD MASTER. **FRANK FABRIZIO** MADE A MOTION TO APPOINT CHARLES FAYASH AS ROADMASTER UNDER THE AGREEMENT OF EXPENSES. FAYASH MUST GET THE BOARD'S APPROVAL OF PURCHASES MORE THAN \$250. SECOND BY FAYASH. *ROLL CALL-ALL APPROVED.* MORE DISCUSSION WAS MADE AMONGST THE BOARD AND THE SOLICITOR AND THE FUTURE POSSIBLE EXPENDITURES.

CHARLES FAYASH MADE A MOTION TO SET THE WAGES OF THE MAINTENANCE DEPARTMENT AT \$15.00 PER HR. MARK BUCCIERI WILL BE PAID \$16.00 FOR ALL MAINTENANCE AND PLOWING. SECONDED BY FABRIZIO. *ROLL CALL-ALL APPROVED.*

CHARLES FAYASH ASKED FOR A MOTION TO APPOINT A POLICE LIASON. **CHARLES FAYASH** MADE A MOTION TO APPOINT FRANK FABRIZIO AS POLICE LIASON. SECOND BY FABRIZIO. *ROLL CALL-ALL APPROVED.*

CHARLES FAYASH MADE A MOTION TO APPOINT FRANK DIMARCO AS TOWNSHIP CODE ENFORCEMENT OFFICER. SECOND BY FABRIZIO. *ROLL CALL-ALL APPROVED.*

CHARLES FAYASH MADE A MOTION TO APPOINT FRANK DIMARCO AS CHIEF & TONY STANELL AS SERGEANT, BOTH AS PART-TIME POLICE OFFICERS. 40 HOURS PER WEEK COMBINED AT A RATE OF \$17.00. SECOND BY FABRIZIO. *ROLL CALL-ALL APPROVED.*
