THE REORGANIZATION MEETING OF THE BOARD OF SUPERVISORS OF SCHUYLKILL TOWNSHIP WAS HELD ON MONDAY 1/4/21 IN THE MUNICIPAL BUILDING AT 6:00PM. MEETING OPENED WITH PLEDGE OF ALLEGIANCE TO THE FLAG. ROLL CALL TAKEN. PRESENT WERE CHARLES FAYASH, CHARLES HOSLER, FRANK FABRIZIO, & COLLEEN BARRETT.

PUBLIC COMMENT ON REORGANIZATION MEETING ITEMS ONLY: NONE  
THE REORGANIZATION MEETING:

THE MEETING STARTED WITH CHARLES FAYASH ASKING FOR A MOTION TO APPOINT A TEMPORARY CHAIRPERSON. FRANK FABRIZIO NAMED CHARLES FAYASH. SECOND BY CHARLES HOSLER. FAYASH TOOK OVER AS TEMPORARY CHAIRMAN. ROLL CALL-ALL APPROVED.

CHARLES FAYASH MADE A MOTION TO APPOINT COLLEEN BARRETT AS TEMPORARY SEC/TREASURER. SECOND BY CHARLES HOSLER. ROLL CALL-ALL APPROVED.

CHARLES FAYASH ASKED FOR A MOTION TO APPOINT A CHAIRPERSON. FRANK FABRIZIO MADE A MOTION TO APPOINT CHARLES HOSLER. SECOND BY CHARLES HOSLER. ROLL CALL -NAY CHARLES FAYASH – MOTION APPROVED.

CHARLES HOSLER MADE A MOTION TO APPOINT FRANK FABRIZIO AS VICECHAIRMAN. SECOND BY FRANK FABRIZIO. ROLL CALL-ALL APPROVED.

CHARLES FAYASH MADE A MOTION TO APPOINT COLLEEN BARRETT AS SECRETARY/ TREASURER AT A PAY RATE OF \$14.50/HR FOR A TOTAL OF 27 HOURS PER WEEK WITH A 2% BONUS ON GARBAGE COLLECTIONS AND \$150 MONTHLY STIPEND FOR PERSONAL VEHICLE USAGE. SECOND BY FRANK FABRIZIO. ROLL CALL-ALL APPROVED.

CHARLES FAYASH MADE A MOTION TO APPOINT MARK BUCCIERI ROAD MASTER. SECOND BY CHARLES HOSLER. ROLL CALL-ALL APPROVED.

CHARLES FAYASH MADE A MOTION TO SET THE WAGES OF MARK BUCCIERI , HE WILL BE PAID \$18.00 FOR ALL MAINTENANCE AND PLOWING. SECOND BY CHARLES HOSLER. ROLL CALL-ALL APPROVED.

CHARLES FAYASH MADE A MOTION TO APPOINT CHARLES FAYASH AS POLICE LIASON. SECOND BY CHARLES HOSLER. ROLL CALL-ALL APPROVED.

CHARLES FAYASH MADE A MOTION TO APPOINT LIGHT HEIGEL ASSOCIATES AS TOWNSHIP CODE ENFORCEMENT OFFICER. SECOND BY FRANK FABRIZIO. ROLL CALL – ALL APPROVED.

CHARLES FAYASH MADE A MOTION TO APPOINT FRANK DIMARCO AS CHIEF & ANTHONY STANELL AS SERGEANT, BOTH AS PART-TIME POLICE OFFICERS AT A RATE OF \$20/HOUR WORKING 40 HOURS PER WEEK COMBINED TOTAL FOR ALL EMPLOYEES OF THE PART-TIME POLICE DEPARTMENT. NO SECOND. QUESTION BY FRANK FABRIZIO.

CHARLES FAYASH MADE A MOTION TO APPOINT DOUGLAS LITWHILER AND JASON LEX AS ADDITIONAL PART-TIME POLICE OFFICERS TO HELP COVER THE 40 HOURS(COMBINED TOTAL) FOR ADDITIONAL COVERAGE FOR MIDDLEPORT BOROUGH AT A RATE OF \$17/HOUR DURING A PROBATIONARY PERIOD OF 90 DAYS WITH A DOLLAR RAISE TO \$18/HOUR AFTER PROBATIONARY PERIOD. NO SECOND. FRANK FABRIZIO MADE A MOTION TO APPOINT DOUGLAS LITWHILER AND JASON LEX AS ADDITIONAL PART-TIME POLICE OFFICERS FOR 30 HOURS A WEEK TOTAL FOR NIGHTS AND WEEKENDS AT A RATE OF \$17/HOUR DURING A PROBATIONARY PERIOD OF 90 DAYS. FAYASH QUESTIONED IF THAT 30 HOURS WAS FOR THE WHOLE YEAR AND IF IT WAS 30 HOURS PER WEEK AND THAT IT ALLOWED FOR 10 HOURS FOR THE OTHER POLICE OFFICERS. DISCUSSION ENSUED ABOUT THE SPECIFICS. FABRIZIO STATED WE NEED THE NIGHTS AND WEEKENDS COVERED BY THE 30 HOURS (OUT OF THE 40 TOTAL) AND THE REMAINING 10 HOURS COULD BE WEEKDAY/DAYTIME. FABRIZIO'S MOTION WAS SECOND BY CHARLES HOSLER. DISCUSSION ENSUED ABOUT COURT APPEARANCES AND NIGHT TIME HOURS (AFTER 7:00PM). HOSLER STATED IF THEY ARE APPEARING IN COURT THERE WILL BE AN EXCEPTION. FABRIZIO MADE A MOTION TO APPOINT DOUGLAS LITWHILER AND JASON LEX AS ADDITIONAL PART-TIME POLICE OFFICERS FOR 30 HOURS A WEEK TOTAL FOR NIGHTS AND WEEKENDS AT A RATE OF \$17/HOUR DURING A PROBATIONARY PERIOD OF 90 DAYS. SECOND BY HOSLER. ROLL CALL – NAY CHARLES FAYASH - MOTION APPROVED.

DISCUSSION ENSUED WITH ATTY BARANKO. CHARLES FAYASH MADE A MOTION TO APPOINT FRANK DIMARCO AS CHIEF/PART-TIME POLICE OFFICER AT A RATE OF \$20/HOUR WORKING 40 HOURS PER WEEK COMBINED TOTAL FOR ALL EMPLOYEES OF THE PART-TIME POLICE DEPARTMENT. SECOND FABRIZIO. ALL APPROVED.
