The Regular meeting of the Supervisors of Schuylkill Township was held on Monday, July 2nd, 2018 in the Municipal Building. Those present included Charles Fayash, Charles Hosler, and Frank Fabrizio. The Pledge of the Allegiance was recited.

Charles Hosler made a motion to approve the June's Regular Meeting Minutes. 2nd Fayash. All approved.

Treasurer's Report

\$418,887.86 total in bank accounts. Charles Fayash made a motion to accept the Treasurer's Report pending audit. 2nd Hosler. All approved.

Answers to Last Month's Public Questions- None

Public comment on agenda items only – None

Police Report – 14 total calls for June. Megan's law issue for Middleport, 8 traffic citations (intersection at 209 Schuylkill Township), burning complaint, theft, parking complaint, domestic, false alarm, trespassing behind the Brockton cemetery – Reading Anthracite's property. DiMarco stated he contacted Reading Anthracite about securing area possibly with a gate. Reading Anthracite told him they would send someone to check it out.

Code Enforcement Report – Another ordinance letter was sent out for Piersol Street in Reevesdale. Property on Dodson Street he has started cleaning up. DiMarco stated he spoke to Plachko's office about the ordinance and giving people time to clean up the area and that the high grass is a separate issue. They can be cited on the high grass separately. Baranko questioned on whether our township had the quality of life ordinance and DiMarco stated no. DiMarco questioned that he had given resident a letter about the junk cars, debris, and high grass then the resident moves some of the cars but doesn't cut grass and he wanted to be sure he could cite them under a different subsection if needed. Neighbors asked about the other property (44). DiMarco stated he would look into it.

Road master Report- Hosler stated that maintenance removed grass and leaves from drains on old 209, cut roadsides, removed fallen trees, hung more flags, filled potholes, building and shop maintenance, trimmed trees, and preventative maintenance on mower.

Solicitors Report-Baranko stated that minor changes were made to Ordinance 2-2018 and it was advertised therefore it is ready to go.

move forward with her service project. The board thought it was a good idea. Magnani questioned if the township would be receiving any compensation for the Zawada pictures. The answer was no.

New Business- Hosler made a motion to approve Ordinance 2-2018 amendment to garbage ordinance. 2nd Fabrizio. All approved. Fire Company merger letter for 9-1-1 was requested by Khris Fessler.
