AN ORDINANCE

OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF SCHUYLKILL, SCHUYLKILL COUNTY, PENNSYLVANIA, SIGNIFYING THE INTENTION AND DESIRE OF THE MUNICIPAL AUTHORITIES OF SAID TOWNSHIP TO ORGANIZE AN AUTHORITY JOINTLY WITH THE BOROUGH OF MIDDLEPORT, SCHUYLKILL COUNTY, PENNSYLVANIA, THE BOROUGH OF NEW PHILADELPHIA, SCHUYLKILL COUNTY, PENNSYLVANIA, THE BOROUGH OF PORT CARBON, SCHUYLKILL COUNTY, PENNSYLVANIA, AND THE TOWNSHIP OF BLYTHE, SCHUYLKILL COUNTY, PENNSYLVANIA, UNDER THE PENNSYLVANIA ACT OF MAY 2, 1945, P.L. 382, KNOWN AS THE "MUNICIPALITY AUTHORITIES ACT OF 1945", AS AMENDED AND SUPPLEMENTED; SETTING FORTH, IN FULL, THE PROPOSED ARTICLES OF INCORPORATION; APPOINTING AND FIXING THE TERMS OF THE FIRST MEMBERS TO REPRESENT THIS TOWNSHIP ON THE BOARD OF SUCH AUTHORITY; AUTHORIZING EXECUTION OF ARTICLES OF INCORPORATION AND THE DOING OF ALL MATTERS NECESSARY FOR CREATION OF SUCH AUTHORITY; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT WITH THIS ORDINANCE.

except that:

A. The municipal authorities of the Township of Blythe, Schuylkill County, Pennsylvania, heretofore organized "The Municipal Authority of the Township of Blythe" under said Act of May 2, 1945, P. L. 382, known as the Municipality Authorities Act of 1945, as amended and supplemented; and

B. The municipal authorities of the Borough of Middleport, the Borough of New Philadelphia, the Township of Blythe and the Township of Schuylkill, were all situated in Schuylkill County, Pennsylvania, heretofore organized the "Schuylkill Valley Sewer Authority" under said Act of May 2, 1945, P. L. 382, known as the Municipality Authorities Act of 1945, as amended and supplemented.

SECTION 3: The Chairman of the Board of Supervisors and the Secretary, respectively, of this Township, acting jointly with appropriate officers of the Borough of Middleport, the Borough of New Philadelphia, the Borough of Port Carbon, and the Township of Blythe, all situated in Schuylkill County, Pennsylvania, hereby are authorized, empowered and directed to cause notice of the substance of this Ordinance, including the substance of the foregoing Articles of Incorporation, and of the proposed filing of such Articles of Incorporation to be published as required by the Act.

SECTION 4: The Chairman of the Board of Supervisors and the Secretary, respectively, of this Township, acting jointly with appropriate officers of the Borough of Middleport, the Borough of New Philadelphia, the Borough of Port Carbon, and the Township of Blythe, all situated in Schuylkill County, Pennsylvania, hereby are authorized, empowered and directed to cause such Articles of Incorporation, together with necessary proofs of publication, to be filed with the Secretary of the Commonwealth of Pennsylvania and to do all other acts and things necessary or appropriate to effect the incorporation of such Authority, including payment of any fees necessary in connection therewith.

SECTION 5: The following named person shall be and he hereby is appointed as the first member to represent this Township on the Board of such Authority for the following term of office:
