TOWNSHIP OF SCHUYLKILL ORDINANCE 78-4

AN ORDINANCE OF THE TOWNSHIP OF SCHUYLKILL PROVIDING FOR THE COLLECTION OF GARBAGE AND OTHER REFUSE MATERIAL BY THE TOWNSHIP AND ESTABLISHING A FEE FOR THE COLLECTION THEREOF

BE IT ORDAINED AND ENACTED by the Board of Supervisors of Schuylkill Township, Schuylkill County, Pennsylvania, hereby ORDAINED and ENACTED as follows:

SECTION 1: It is hereby found and determined that the periodic collection of garbage from all places in the Township of Schuylkill benefits all occupants of places and premises in the Township, and such occupants or persons in possession, control, ownership or charge of any place in or from which garbage is collected, accumulated or produced are liable and shall pay the garbage collection fee established by the Board of Supervisors of the Township of Schuylkill. The Township shall arrange and provide for the collection and disposal of garbage, rubbish, ashes and other refuse material within the geographical limits of the Township and it shall be mandatory for all occupants or persons in possession, charge, ownership or control of places or premises in the Township of Schuylkill in or from which garbage is created, accumulated or produced to use the Township's collection service.

SECTION 2: A garbage collection and disposal fee in the amount of five (\$5.00) dollars per annum is hereby imposed upon each business premises and upon each dwelling unit within the geographical limits of the Township.

SECTION 3: The garbage collection and disposal fee imposed by this ordinance shall be paid to the Township Tax Receiver on an annual basis, payable within thirty (30) days from the date of assessment.

SECTION 4: Failure to pay the fee imposed hereby shall result in imposition of a penalty in the amount of five (\$5.00) dollars per month and said fee and penalties may be collected from responsible party as provided by law, and the responsible party shall be liable for all costs of such action.

SECTION 5: The Board of Supervisors of the Township of Schuylkill shall have the right to appoint by resolution those individuals responsible for the fulfillment and enforcement of this ordinance and the right to promulgate from time to time by resolution such rules and regulations necessary for the proper execution of this ordinance, including but not limited to containerization, placement of containers, location of containers for collection, and date of collection.

SECTION 6: All ordinances or resolutions, or parts of ordinances or resolutions, insofar as they are inconsistent herewith be and the same are hereby repealed.

SECTION 7: If any sentence, clause, section or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this ordinance. It is hereby declared as the intent of the Board of Supervisors of the Township of Schuylkill, that this ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
