

TOWNSHIP OF SCHUYLKILL

ORDINANCE NO. 80-2

AN ORDINANCE LAYING OUT, OPENING AND ADOPTING AS PUBLIC STREETS IN THE TOWNSHIP OF SCHUYLKILL, SCHUYLKILL COUNTY, PENNSYLVANIA STREETS TO BE KNOWN AS BROAD STREET, ORE STREET, WALNUT STREET, FOREST LANE, SUNNY DRIVE, BACK STREET, GREEN STREET, WOODLAWN STREET, AND FIXING AND REGULATING THE WIDTH AND GRADES THEREOF.

WHEREAS, it is the desire of the Board of Supervisors of Schuylkill Township to ordain the following streets as they are hereafter more particularly described;

NOW, THEREFORE, be it ordained and enacted by the Board of Supervisors of the Township of Schuylkill as follows:
