ORDINANCE NO. 85-2

TOWNSHIP OF SCHUYLKILL

AN ORDINANCE ESTABLISHING GUIDELINES FOR COMPENSATION OF TOWNSHIP SUPERVISORS ELECTED OR APPOINTED TO OFFICE ON OR AFTER NOVEMBER 5, 1985.

BE IT ORDAINED by the Board of Supervisors of Schuylkill Township, Schuylkill County, Pennsylvania, and it is hereby ordained by the authority of the same as follows:

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania has enacted Act 68 of 1985 setting forth certain guidelines and limitations for the compensation of Supervisors of Townships of the second class; and

WHEREAS, said Act provides that Supervisors of Townships having a population of Zero (0) to Four Thousand Nine Hundred Ninety-nine (4,999) shall be compensated in an amount not to exceed One Thousand Five Hundred (\$1,500.00) Dollars; and

WHEREAS, the population of Schuylkill Township is One Thousand Five Hundred Sixteen (1,516); and

WHEREAS, the General Assembly by said Act 68 authorizes the Boards of Supervisors of the various Townships of the second class to determine the compensation of Supervisors subject to the limitations set forth in the Act; and

WHEREAS, it is the intention of the Board of Supervisors of Schuylkill Township to set compensation for Supervisors on a per meeting basis and within the limitations of Act 68.

NOW, THEREFORE, it is hereby enacted and ordained as follows:

1. Each Supervisor of Schuylkill Township elected or appointed to office on or after November 5, 1985, shall receive compensation for attending

duly advertised general or special public meetings of the Board of Supervisors at the rate of One Hundred Twenty-five (\$125.00) Dollars for each meeting attended by such Supervisor.

- 2. No Supervisor shall receive annual compensation under this ordinance in excess of the annual statutory limit set by the General Assembly in Act 68 for Supervisors of Townships within the appropriate population category.
- 3. No Supervisor shall be compensated for attending any meetings of the Board of Supervisors in excess of Twelve (12) meetings per year; such absences of compensation shall not negate or in any way affect such Supervisor's duty or obligation to attend such uncompensated meetings.
 - 4. Such compensation shall be paid in monthly installments.
 - 5. This Ordinance shall be effective January 1, 1986.
