

TOWNSHIP OF SCHUYLKILL

ORDINANCE 87-2

AN ORDINANCE ADOPTING NO PARKING ZONES AND
SNOW EMERGENCY ROUTES IN COMPLIANCE WITH THE
PENNSYLVANIA VEHICLE CODE.

BE IT ORDAINED AND ENACTED by the Board of Supervisors
of Schuylkill Township, Schuylkill County, Pennsylvania, as follows:

Section 1. The following locations are designated as
no parking zones:

A. Brockton

1. Lewis Street (on both sides)
for a distance of Forty (40.00') Feet West of
the intersection with Mine Street.

2. Lewis Street (on both sides)
for a distance of Forty (40.00') Feet East of
the intersection with Mine Street.

3. Mine Street (on both sides) for
a distance of Thirty (30.00') Feet South of
the intersection with Lewis Street.

4. Between signs located on Lewis
Street across from Woodland Street where
indicated.

5. Mine Street (on both sides) for
a distance of Seventy (70.00') Feet North of

the intersection with Valley Street.

6. Valley Street for a distance of Three Hundred Twenty-seven (327.00') Feet from the intersection of Mine Street (on the North side) and Seventy-two (72.00') Feet (on the South side).

7. Valley Street (on both sides) for a distance of Two Hundred Thirty (230.00') Feet beginning Forty-four (44.00') Feet West from the intersection of Emerick Street.

8. West Green Street (South side) for a distance of One Hundred Ten (110.00') Feet from the intersection with Mine Street between 7:00 A.M. and 9:00 A.M. and 2:30 P.M. and 4:30 P.M.

B. Mary-D

Back Street from the intersection with Sunny Drive on North side in an Easterly direction for One Hundred Thirty-two (132.00') Feet on the South side in an Easterly direction for One Hundred Eighty (180.00') Feet.

C. Tuscarora

1. Walnut Street Three Hundred Twenty-seven (327.00') Feet East of the intersection with Tioga Street, on the South side for a distance of Ninety-four (94.00') Feet on the North side for a distance of Two Hundred (200.00') Feet.

2. Broad Street (on both sides) from the intersection with Coal Street to the intersection with Mulberry Street (at specified times when duly posted).

3. West side of L.R. 53036 (a/k/a Catawissa Street) from the intersection with T-505 in a Southerly direction for Two Hundred Ninety-eight (298.00') Feet.

4. East side of L.R. 53036 (a/k/a Catawissa Street) from the intersection with Chestnut Street in a Southerly direction to Walnut Street.

5. East side of L.R. 53036 (a/k/a Catawissa Street) from the intersection with Walnut Street in a Southerly direction for Eighty-six (86.00') Feet.

Section 2. Both sides of the following streets are designated as the Emergency Snow Route:

A. Beginning at Schuylkill Township line, Brockton, going East on Old Route 209 to the intersection, Schuylkill Township Route 505 Mary-D, going North on Route 505 to intersection with Old Route 209, Tuscarora then continuing East to Odd Fellows Cemetery and intersection U.S. Route 209.

B. Brockton-From Mine and Green Streets East to Green and Union Streets.

C. Tuscarora-From Strawberry Street South to Walnut Street, then from Mulberry Street and Wyoming Street South to Walnut Street, then from intersection of Mulberry Street West to the intersection of Strawberry Street.

Section 3. Any person violating any of the provisions of this ordinance shall be subject to a fine as follows: five (\$5.00) dollar fine payable to Schuylkill Township if paid within five (5) days. If the offender (car owner) fails to pay the same within the five (5) day period, a summary citation shall be issued pursuant to the Pennsylvania Vehicle Code.
