A RESOLUTION
REQUESTING PERMISSION TO PARTICIPATE IN THE PENNSYLVANIA DEPARTMENT
OF GENERAL SERVICES COOPERATIVE PURCHASING PROGRAM

Whereas, Act 57 of May 15, 1998 permits local public procurement units to participate in those contracts for supplies, services, or construction entered into by the Department of General Services (DGS) that are made available to local public procurement units. A "local public procurement unit" is defined as: any political subdivision, public authority, educational, health, or other institution; and to the extent provided by law, any other entity, including a council of governments or an area government; nonprofit fire, rescue, or ambulance company; and any nonprofit corporation operating a charitable hospital.

Be it resolved, that the Supervisors of the Township of Schuylkill hereby requests authorization to participate in DGS's contracts for the procurement of supplies, services or construction, subject to the following conditions:

1. That the Supervisors of the Township of Schuylkill, agrees to be bound by such contract terms and conditions DGS may prescribe.
2. That the Supervisors of the Township of Schuylkill agrees to be responsible for payment directly to the contractor under each contract for those supplies, services or construction ordered by the local public procurement unit.
