**WITNESSETH:**

**WHEREAS, SECTION 7503 OF THE PENNSYLVANIA EMERGENCY MANAGEMENT SERVICE CODE, 35 PA. C.S.A. SECTION 7101 ET SEQ. MANDATES THAT SCHUYLKILL TOWNSHIP PREPARE, MAINTAIN AND KEEP CURRENT AN EMERGENCY OPERATIONS PLAN FOR THE PREVENTION AND MINIMIZATION OF INJURY AND DAMAGE CAUSED BY MAJOR EMERGENCY OR DISASTER WITHIN THE TOWNSHIP: AND**

**WHEREAS, IN RESPONSE TO THE MANDATE STATED ABOVE, THIS TOWNSHIP HAS PREPARED AN EMERGENCY OPERATIONS PLAN TO PROVIDE PROMPT AND EFFECTIVE EMERGENCY RESPONSE PROCEDURES TO BE FOLLOWED IN THE EVENT OF A MAJOR EMERGENCY OR DISASTER; AND**

**WHEREAS, THIS TOWNSHIP HAS ALSO PREPARED AN EMERGENCY OPERATIONS PLAN IN ORDER TO REDUCE THE POTENTIAL AFFECTS OF A MAJOR EMERGENCY OR DISASTER AND TO PROTECT THE HEALTH, SAFETY AND WELFARE OF THE RESIDENTS OF THE TOWNSHIP:**

**NOW, THEREFORE, WE THE UNDERSIGNED SUPERVISORS OF SCHUYLKILL TOWNSHIP, DO HEREBY APPROVE, ADOPT AND PLACE INTO IMMEDIATE EFFECT THE EMERGENCY OPERATIONS PLAN OF SCHUYLKILL TOWNSHIP. THIS PLAN SHALL BE REVIEWED ON AN ANNUAL BASIS TO MAKE CERTAIN THAT IT CONFORMS WITH THE REQUIREMENTS OF THE SCHUYLKILL COUNTY EMERGENCY OPERATIONS PLAN.**
