WHEREAS, THIS TOWNSHIP HAS ALSO PREPARED AN EMERGENCY OPERATIONS PLAN IN ORDER TO REDUCE THE POTENTIAL AFFECTS OF A MAJOR EMERGENCY OR DISASTER AND TO PROTECT THE HEALTH, SAFETY AND WELFARE OF THE RESIDENTS OF THE TOWNSHIP:

IOW, THEREFORE, WE'THE UNDERSIGNED SUPERVISORS OF SCHUYLKILL TOWNSHIP, DO HEREBY APPROVE, ADOPT AND PLACE INTO IMMEDIATE EFFECT THE EMERGENCY OPERATIONS PLAN OF CHUYLKILL TOWNSHIP. THIS PLAN SHALL BE REVIEWED ON AN ANNUAL BASIS TO MAKE ERTAIN THAT IT CONFORMS WITH THE REQUIREMENTS OF THE SCHUYLKILL COUNTY
