John Zubris – Brockton – Thanked the Board for fixing the urinal.

Tracey Ritz – Mary D – Asked what the Twp was doing regarding John Swenson's property on Back Street. Discussion ensued regarding her living at the property since 1999 and dealing with him and his property since that time. Per Mike Kellet, Jacey has pictures of Swenson washing his hands with gasoline. Per Supervisors Feathers we have been citing him and the officers are doing what needs to be done. The Township is following the process that needs to be completed. Swenson is allowed to be in his vehicle on the street it is a public street, discussion ensued regarding the garbage, the smell and the cats are all over and terrible to look at. Discussion ensued regarding the generator he runs, per supervisors they need to call at the time that it is happening so that can be taken care of at the time it is happening. Per Mike Kellet, the trailer isn't inspected along with other violations; garbage is being added to the trailer. Per Supervisor Feathers the trailer is taken care of. Discussion ensued with Mike Kellet with how long this has been going and has been reported to Board in the past. Per Supervisor Feathers we are working out the legalities with Marty from Light & Heigel. Kellet is waiting on Marty to answer questions he has asked Marty and Marty hasn't responded to him. Also inquired about the garbage and what we are doing about that. Hill stated Tamaqua Transfer has been told several times not to pick up the garbage. Kellet questioned who is code enforcement. Kellet inquired about 79 Back Street, Marty says Swenson can be there and DiMarco says he can't be there. Who are they suppose to listen to and believe. They posted 79 Back Street on Thursday June 2<sup>nd</sup>, per Hill it was posted in c/o John Swenson due to no other siblings have stepped forward. Discussion ensued.
