Old Business: George Yatsko handicap parking space to be placed across the street from house. Discussion ensued with the supervisors regarding the handicap parking spot and the area. Supervisors will take a look at the area and decide.

Discuss ESRP, ESRP met on May 10th to discuss the modifications of the Zoning Amendments, 1st Approve the Attorney General's recommendations regarding the egg farm in Walker Twp, 2nd Allow Solar panels on R-4 residents with out having to go through variance or special exception, 3rd Allowing accessory structures to be put up on properties that doesn't have a house as long as the property is adjacent to principal property, it can be across the street and 4th Swapping G-1 with G-2, it gives the ability for a dirt bike track etc on the area that the RORR Races are already held. Discussion ensued regarding the G-1 with G-2. Discussion ensued regarding the maps being redone. Our Planning Commission needs to meet and approve the ESRP Amendments prior to our July Meeting.

New Business: Roller Bid-Discussion ensued regarding placing a bid with Rush Twp. Feathers made motion of \$1401.00 to place bid on roller & trailer, 2nd Fayash, All Approved. Mike Boyle handicap parking spot for his business-Discussion ensued regarding placement of spot. Per Feathers Boyle takes responsibility for painting and installing the sign, Fayash motioned for handicap parking space for Boyle Productions Services on Firehouse Rd by his business, 2nd Hosler. All Approved. Handicap parking application for Twp. Hill reached out to Tamaqua Borough, Walker Twp and Rush Twp. Discussion ensued the regarding the application from Tamaqua Borough and changes needed for our Twp. and resolution needs to be modified. Fees were discussed regarding installation and yearly fee. Fayash made motion for solicitor to review handicap application and modify resolution as needed for handicap parking and \$100 to install and \$25 yearly. 2nd Feathers. All Approved. Hill obtained permission to place \$5 Moving In/Out Permit on the Website. Discussion ensued regarding No Name alley in Tuscarora, off of Broad Street to Seneca with Mr. & Mrs. Machay regarding ownership of road. Supervisors ensured it can not be blocked and access should be open. Valerie Brown requested grant thru Affordable Housing for 245-249 Washington St in Brockton and is looking for supervisors for support. Hill discussed Brown's proposed plans. Supervisors are unable to support without having all the information to support. Feathers motioned to pay Benesch Invoice for \$1548.00, 2nd Hosler. All approved. Discussion ensued regarding parking on Walnut Street @ Catawissa St intersection, Fire Trucks are having a hard time getting around when vehicles are parked there. Fayash motioned for Baranko to look into a No Parking Ordinance from Strawberry to Catawissa on both sides of Walnut Street, 2nd Feathers. All Approved
