The Workshop meeting of the Supervisors of Schuylkill Township was held Monday, September 21, 2022. Those present included Charles Fayash, Gary Feathers and Charles Hosler. The Pledge of the Allegiance was recited.

Communications: None

Old Business: Hometown Hero Flags-next steps to move forward – discuss flag and amount, Hill suggesting setting price at \$225 this includes Bracket, Banner and installation, Hill asked for the October meeting for the board to choose a Banner, The Banners will be hung by completed application and fee paid, Residents can place the pole number they would like flag hung on HTH application, however it is not guarantee to be hung on that pole. At this time PPL poles are the only ones to give permission to use their poles and information as to how it is to be hung on their pole; Per John Gilbert from the program Banner placement on poles will be determined in Feb 2023 once all applications, pictures and payments are received. If any Banner becomes damaged the family is responsible to pay for a replacement Banner, not the township. Discussion ensued placing the Banners on the pole. Supervisors don't mind what street the Banner is placed. Discussion ensued regarding pictures and picture sizes on the Banner. Hill will have HTH application and banners for board to chose from for October's meeting. Door Proposal-warranty discuss, per ABE 1 year commercial warranty on the door; Schuylkill Township's owned property-discuss timbering email, per Hill Atty Baranko asked for the Board to review this Timbering packet he sent prior to October's meeting, last time township looked into this was 2017, Feathers asked Hill to reach out to DCNR to get help with the inquiry; Discussion ensued regarding looking at all the township property that is owned and what can be cut; Review Act 57 Local Tax Collection Law-discuss, waiver for first time homeowner who didn't receive their tax bill can dispute by proving they did not receive the tax bill; Excessive Road Maintenance & Bonding agreement-discuss email, engineer is in contact with Atty Baranko, Atty Baranko would like the board to review it and let him know of any questions or changes needed, discussion ensued regarding the permitting and bonding for the road; General Code Project-discuss, Hill sent links for supervisors to register with Ecode; Garbage Delinquencies – garbage has been stopped to any resident with an outstanding balance over \$300 as of 9/20/2022 and no payment plan set up-letters were mailed 8/19/2022 to residents: Employee Mark Buccieri – discuss benefits and rate in exec. Session
