ORDINANCE NO. 93-/

AN ORDINANCE OF SCHUYLKILL TOWNSHIP, SCHUYLKILL COUNTY, PENNSYLVANIA, RECOGNIZING THE TUSCARORA FIRE COMPANY, MARY-D FIRE COMPANY AND BROCKTON FIRE COMPANY AS THE OFFICIALLY RECOGNIZED FIRE COMPANIES TO PROVIDE FIRE PROTECTION AND RELATED SERVICES TO THE TOWNSHIP OF SCHUYLKILL; AUTHORIZING ACTIVITIES OF THE FIRE COMPANIES, OFFICERS, AND MEMBERS OF THE FIRE COMPANIES FOR THAT PURPOSE; DEFINING FIREFIGHTING DUTIES AND PROVIDING ADDITIONAL PROTECTION TO FIREFIGHTERS UNDER THE PENNSYLVANIA WORKMEN'S COMPENSATION ACT.

<u>SECTION I. - FIRE COMPANIES RECOGNIZED</u> <u>BY THE TOWNSHIP OF SCHUYLKILL</u>

The Tuscarora Fire Company, Mary-D Fire Company, and Brockton Fire Company duly organized and existing in the Township of Schuylkill, County of Schuylkill, and Commonwealth of Pennsylvania, are hereby designated as the officially recognized fire companies of the Township of Schuylkill.

SECTION II. - AUTHORIZED ACTIVITIES OF THE FIRE COMPANIES

- A. The fire companies recognized by the Township are hereby authorized to provide such services to the Township as may be necessary for the protection of property and persons situate therein, which include, by way of example, and not of limitation, the extinguishment of fire and the prevention of loss of life and property from fire, automobile accidents, hazardous materials incidents, and other dangerous situations.
 - B. The fire companies may also provide non-emergency

and public service functions, including but not limited to, removal of water from property after storms, and assisting in the removal, abatement and prevention of injury or damage to persons or property, whether through natural causes or man made disasters or situations.

- C. The fire companies may also conduct and participate in such training activities, exercises and drills, either within or outside of the geographical limits of the Township, as may be deemed necessary and appropriate by the officers of the companies to maintain necessary proficiency in providing service.
- D. The fire companies may also respond to calls and provide services to municipalities outside of the Township's geographical limits.

SECTION III. - AUTHORIZED ACTIVITIES OF THE MEMBERS OF THE FIRE COMPANIES

- A. In addition to the fire companies participating in the activities authorized above in Section II. of this Ordinance, or in going to or returning from any authorized activity, the members of the fire companies are also authorized to conduct the following activities:
 - 1. Engage in any type of drill, training, practice, test, parade, ceremony when such activities are duly called for or authorized by an officer(s) of the fire companies;
 - 2. Engage in any type of fund raising activity for the fire companies, when authorized by an officer(s) of the fire companies, and the Board of

Supervisors of Schuylkill Township.

SECTION IV. - PURPOSE

The purpose of this Ordinance is to recognize the Tuscarora Fire Company, Mary-D Fire Company, and Brockton Fire Company as the official fire companies of the Township of Schuylkill, and to define the additional authorized activities for firefighters for liability and workmen's compensation purposes.

SECTION V. - EFFECTIVE DATE

This Ordinance shall become effective immediately.
