ORDINANCE NO.: 2022-

AN ORDINANCE OF THE TOWNSHIP OF SCHUYLKILL, COUNTY OF SCHUYLKILL, COMMONWEALTH OF PENNSYLVANIA, ESTABLISHING A NO PARKING ZONE ON WALNUT STREET BETWEEN STRAWBERRY STREET TO ITS INTERSECTION WITH CATAWISSA STREET.

BE IT ORDAINED AND ENACTED and it is hereby ordained and enacted by the Board of Supervisors of the Township of Schuylkill, County of Schuylkill, Commonwealth of Pennsylvania as follows:

Article 1. Definitions and Interpretation. Words and phrases, when used in this Ordinance, shall have the meaning ascribed to them in the Vehicle Code of Pennsylvania as now enforced or as hereafter amended, enacted, or reenacted, except in those instances where the context clearly indicates a different meaning. The singular shall include the plural and the masculine shall include the feminine.

Article 2. Establishment of No Parking. That portion of Walnut Street from Strawberry Street to its intersection with Catawissa Street is hereby declared to be a No Parking Zone. There shall be no parking on either side of Walnut Street between Strawberry Street and its intersection with Catawissa Street and No Parking by any motor vehicle shall be permitted within this corridor. Official No Parking signs shall be erected to be consistent with this Ordinance.

Article 3. Penalty for Violation. Any person who shall violate any of the provisions of this Ordinance shall, upon conviction thereof, be sentenced to pay a fine of \$100.00 and costs of prosecution and shall be enforced as a summary offense and enforcement shall be by action brought before a District Justice in the same manner provided for the enforcement of summary offenses under Pennsylvania Rules of Criminal Procedure.

<u>Article 4. Enforcement</u>. This Ordinance shall be enforced by the Schuylkill Township Police Department.

Article 5. Inconsistent Ordinances Repealed. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed insofar as the same may be in conflict with this Ordinance.

Article 6. Severability. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Ordinance.

It is hereby declared as the intent of the Board of Supervisors that this Ordinance would have been adopted and such unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not been included herein.

Article 7. Effective Date. This Ordinance shall take effect immediately upon adoption by the Board of Supervisors of Schuylkill Township.
