

AN ORDINANCEADOPTING, OPENING, AND LAYING OUTA PUBLIC ROAD IN SCHUYLKILLTOWNSHIP, TO BE KNOWN AS WOODLANDROAD.

Schuylkill Township hereby enacts and ordains as follows:-

Section 1.- The following road or street, hereby designated as Woodland Road, and extending for a distance of about 632 feet and located in the Village of Brockton, Schuylkill Township, beginning at a point on the north side of Lewis Street, thence northwardly to its terminus, is hereby laid out and adopted as a public highway of Schuylkill Township to a width of forty (40') feet, together with a twenty (20') feet wide alley extending eastwardly at right angles to Woodland Road for a distance of 120 feet.

Section 2.- The center line of said public highway shall be a line located midway between the sides of the strip of land comprising the area of said road, which area is bounded and described as follows:-

"Beginning at an iron pin at the north line of Lewis Street, the southwest corner of Michael Slepceki property and the southeast corner of this conveyance; thence along the north line of said Lewis Street South Eighty-nine Degrees Ten Minutes West (S 89° 10' W) Forty (40.0') feet, to a point, at the southeast corner of Stephen Kristoff property; thence along the east line of said Kristoff property and John Zelonis property North Zero Degrees Fifty Minutes West (N 0° 50' W) One Hundred Eighty (180.0') feet to a stake, the northeast corner of said Zelonis property and the southeast corner of Lot No. 1; thence along the east line of Lots Nos. 1, 2, 3, 4 and 5 North Five Degrees Thirty-eight Minutes West (N 5° 38' W) Four Hundred Fifty-two (452.0') feet, to a stake, the northeast corner of said Lot No. 5; thence North Eighty-nine Degrees Ten Minutes East (N 89° 10' E) Forty (40.0') feet to a stake, the northwest corner of Lot No. 6; thence along the west line of Lots Nos. 6, 7, 8, 9 and 10 South Five Degrees Thirty-eight Minutes East (S 5° 38' E) Four Hundred Fifty-one and Five Tenths (451.5') feet, to a stake at the west line of said Lot No. 10; thence along the west line of said Lot No. 10 South Zero Degrees Fifty Minutes East (S 0° 50' E) Ten (10.0') feet, to a stake, at the southwest corner of said Lot No. 10; thence along the south line of said Lot No. 10 North Eighty-nine Degrees Ten Minutes East (N 89° 10' E) One Hundred Twenty (120.0') feet, to a point, at the southeast corner

of said Lot No. 10; thence South Zero Degrees Fifty Minutes East (S 0° 50' E) Twenty (20.0') feet, to a point, at the northeast corner of Walter Schaeffer property; thence along the north line of said Schaeffer and Sipecki properties South Eighty-nine Degrees Ten minutes West (S 89° 10' W) One Hundred Twenty (120.0') feet, to an iron pin, at the northwest corner of said Sipecki property; thence along the west line of said Sipecki property South Zero Degrees Fifty Minutes East (S 0° 50' E) One Hundred Fifty (150.0') feet, to the place of beginning.

Section 3. - All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.
