TAX LEVY RESOLUTION

RESOLUTION NO. 98-6

A RESOLUTION OF THE Home Rule Municipality of TOWNSHIP OF SCHUYLKILL County of SCHUYLKILL, Commonwealth of Pennsylvania, fixing the tax rate for the year 19 98.

BE IT RESOLVED AND ENACTED, and it is hereby resolved and enacted

by the SUPERVISORS of the TOWNSHIP of SCHUYLKILL, Governing Body of Home Rule Municipality Board of Township Supervisors of the Township of SCHUYLKILL County of SCHUYLKILL, Commonwealth of Pennsylvania:

That a tax be and the same is hereby levied on all real property within the TOWNSHIP OF SCHUYLKILL subject to taxation for the fiscal year 1999, as follows: Township, Home Rule Municipality
